### Minimum Requirements for Construction Plans

- ✓ Minimum Sheet Size - 11"x17"
- ✓ Plans Must be Drawn to Scale - 1/4" or 1/8" per foot
- ✓ Plans Must be Drawn with Straight Edge or CAD
- ✓ Show all Doors, Windows, Equipment, & Fixtures
- ✓ Label all Rooms and Provide Dimensions
- ✓ Identify all Load-Bearing Walls, Headers, & Beams
- ✓ Plans must be Legible & include Project Address
- ✓ Designer's Name & Contact Info must be on Plans
