

UNIVERSITY AREA CONTROLLED VEHICULAR PARKING PROGRAM 2008-2009

On-street parking within delineated Parking Program Zones is restricted to neighborhood residents, businesses and visitors. A City of Gainesville DECAL or PERMIT is required for parking in the Program Zones Monday through Friday from 8:00 am to 4:00 pm. Decals and Permits are valid from the date of issue to September 30th, 2009. The City of Gainesville Decals and Permits are ZONE SPECIFIC.

ZONES 1, 2 & 5

Decal issued must be affixed permanently to the lower left corner of the vehicle's windshield. Failure to properly display the permit may result in a citation. Decal is vehicle specific.

ZONES 3 & 4

Permit is a hang tab that must be displayed on the rear view mirror facing the front of the vehicle. Failure to properly display the permit may result in a citation.

FRATERNITY/SORORITY

Meal time decals must be affixed permanently to the lower left corner of the vehicle's windshield. Decal is valid Monday through Friday from 11:00 am to 1:30 pm. Decal is vehicle specific.

COMMERCIAL PERMITS

Issued to businesses in the area, permit is a hang tab that must be displayed on the rear view mirror facing the front of the vehicle. Permit is Zone Specific. Failure to properly display the permit may result in a citation.

SERVICE VEHICLE PERMITS

Issued to service vehicles (i.e., lawn care, plumbing), permit is a hang tab that must be displayed on the rear view mirror facing the front of the vehicle. Permit is valid in all Program Zones. Failure to properly display the permit may result in a citation.

ENFORCEMENT

Traffic Technicians are assigned to the program areas Monday through Friday from 8:00 am to 4:00 pm for the purpose of issuing citations to violators. Those found in violation of Ordinance 26 – 47(a)(3)b will be issued a citation. Illegal use of decal or permit may be subject to a penalty (see Code of Ordinance Appendix A).

DECAL ASSIGNED TO VEHICLE

Where decals are assigned (Zones 1, 2 & 5), only one decal can be issued per vehicle. Decals are vehicle specific and cannot be transferred to another individual or vehicle. Vehicle is registered with the City's Finance Department at the time of application for a decal. In case decal privileges are revoked for a specific vehicle, such vehicle will receive a citation each time it is found parked on-street in the Program Zones.

New Vehicle - New Tag or Same Tag
(See Code of Ordinances Appendix A for fees)

New Tag - If a new tag number is issued to you, you must notify the City's Finance Department of this change by calling (352) 334-5024
Notification could save you an unwanted citation.

LOST/STOLEN DECALS OR PERMITS

If decal or permit is lost, stolen or damaged, proof must be submitted of decal or permit purchase (i.e., receipt, decal remnant or tag number of vehicle). The old decal or permit will be voided. A citation will be issued each time a voided decal or permit is found in use. There will be a replacement fee (see Code of Ordinances Appendix A).

APPEALS BOARD

The Appeals Board will:

1. Hear appeals from property owners, managers or other affected individuals who allege a hardship is created by the regulations due to unique conditions associated with their property or its residents;
2. Reinstate revoked decals or permits.

**My permit has been revoked.
How do I appeal?**

Submit appeal in writing to the City within 10 days of receipt of notification of revocation of privileges, and pay a fee. If the decal or permit is reinstated the fee will be refunded in full. If the Board revokes the decal or permit for the remainder of the program year, appellant must return the decal or permit to the City, and pay a Reinstatement Fee for the next program year. (See Code of Ordinances Appendix A for fees).
