In Accordance with Resolution No. 2010-091050, Appendix H, titled "Fire Flow Mitigation Credit Policy," eligibility requirements state that:

"Parcels subject to a fire services special assessment may be granted a fire flow mitigation credit applied to the *Net Factored Fire Protection Units* calculated for the buildings located on the parcel. Parcels containing buildings protected by an automatic sprinkler system that fully meets the requirements of NFPA 13, NFPA 13D, or NFPA 13R, which is approved by the City and installed, inspected, monitored, and maintained in accordance with the State's adopted standards ("Certified Fire Sprinkler Systems") are eligible for a 10% reduction in *Net Factored Fire Protection Units* assigned to the building(s). The Property owner must provide proof of proper operation and maintenance annually to receive credit."

**Please include a copy of the *invoice only* from the most recent sprinkler inspection conducted within the 12 months prior to the due date.**
